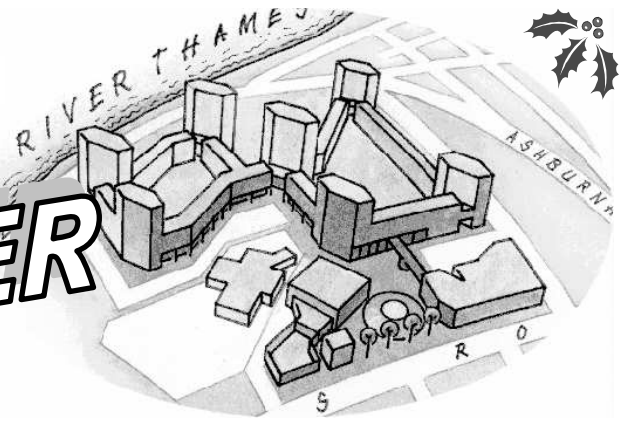

## World's End Residents' Association (WERA)

These last couple of months have been a particularly busy time for the WERA committee.

The committee has worked with the TMO to fill the post of Estate Manager on World's End, a post that had remained vacant for far too long. We welcome Alasdair Manson, our new Estate Manager, to our community and wish him all the best in helping make our Estate a safer and better place to live.

The committee has continued to consult with the Council as to the nature and timing of the proposed capital works, which we hope will change our Estate for the better.

The committee has also been working in tandem with its Leaseholder Sub-group to reduce the burden of service charges on leaseholders. This culminated in the open meeting held in November where officers of the Council and TMO were present and these matters were discussed.

Finally, the committee has been working hard to guarantee that WERA itself will continue to function as well in future as it has done these past few months. All committee members have been made fully aware of their responsibilities and duties under the association's constitution, and Rules of Conduct for the committee have been drawn up and approved. We want WERA to function properly and be fully accountable to the membership and hope these changes will ensure that is the case both now and in the future.



## Leaseholder Sub-group

The Leaseholder Sub-group has been working hard to identify how leaseholders on the Estate can best deal with high service charges which are a result of the capital works planned by the Council.

The group has sought legal advice from LEASE, the leasehold advisory service, to try and determine the exact legal position in which leaseholders now find themselves, and identify any possible legal recourse with regard to the proposed service charges. This work is still ongoing.

Following the recent failure of the Common Parts Grant application, and with the help of LEASE, the group has been trying to identify other ways by which those leaseholders least able to pay may best be helped. With the aid of WERA, the group is currently progressing this matter further with the Council and TMO.

## World's End Management Organisation (WEMO)

WERA is working hard to achieve Local Management - management by and for residents - for the World's End Estate.

As part of this process a new organisation has been created to manage the Estate on our behalf, the "World's End Management Organisation", "WEMO" for short. Following the open meeting in July at which residents approved the constitution and rules of WEMO, the organisation has been registered as a friendly society with the Registrar of Friendly Societies. WEMO is a non-profit organisation owned by its members. All residents of the World's End Estate are welcome to become members by the purchase of a single share. Shares will become available shortly.

The committee is currently negotiating the final version of the management agreement with the Council. The management agreement details those tasks that WEMO will manage on World's End on behalf of the Council and instead of the TMO. Once the management agreement has been agreed residents will be balloted as to whether or not they want WEMO to manage the Estate. If the ballot is successful, WEMO hopes to begin managing the Estate by the summer.

WEMO intends to hold its first AGM during the first three months of next year. Residents will be notified at least 14 days in advance and will have ample opportunity to purchase a share before the AGM so that they may vote. The main order of business will be the election of the organisation's committee and officers.

Nick will be running a mobile phone security marking scheme from the office during the opening hours, so if anyone would like their phone marked bring them along.

The local Police are working closely with the TMO, Community Education, Worlds End Youth Club, and most importantly, residents, to make improvements on the Estate. The police can only do this with the help of the community. The police welcome residents coming forward to report community problems such as anti-social behaviour and low level crime such as broken windows, graffiti, etc. If residents take pride in the Estate, which the majority do, and get the support from the police and organisations such as the TMO, we can make some great changes to the Estate.

The police would like to thank the residents for their support over the past year that saw the closure of several addresses used for drugs on the Estate - this was only possible through the partnership of residents, the police and the TMO.
